Membership is conditional upon Committee approval and payment of the prescribed one-time entrance fee and annual subscriptions.

SECTION C: Entrance Fee and Annual Subscription

An Entrance Fee in the amount of S\$500 is payable within two (2) weeks of approval of the application for membership, in default of which the approval for membership may be withdrawn by the Committee.

Annual Subscription Fees is the amount of S\$500 shall be payable in each financial year commencing 1st July through to 30th June.

Annual subscription are payable in advance and within 30 days from date of invoice.

If the annual subscription is not received with 2 months, the President may order that the company be denied privileges of membership until such time the account is paid in full.

Subscriptions not received more than 3 months of their being due will result in the defaulting member automatically ceasing to be a member of the Association. Thereafter, the Committee may seek recourse against that member for recovery of all arrears outstanding.

SECTION D: Cancellation of Membership

Affiliate Membership can be cancelled should you breach the Association's constitution, code of Ethical conduct, and/or accepted business practices within the Strata Management industry. There will be no refund if your membership is cancelled.

No refund will be provided by the Association should you wish to voluntary cancel your membership during the membership year. Notice for membership cancellation shall be admitted to the Association in writing.
